By submitting this application, you agree to abide by the following rules:

1. All gardeners must complete a yearly application form and pay their plot fee(s) of \$15.00.
2. All garden rental fees are non-refundable.
3. All gardeners must respect their own garden space and the gardens of others by keeping their sites tended. This includes keeping plots weeded. Wind-borne weed seeds and creeping crabgrass are a shared problem in close-quarter gardening.
4. Your experience at the garden will be more enjoyable when you work with your neighbors on issues such as planting and gardening methods. Understanding and communication are key elements of a Community Garden experience and are a responsibility shared by all.
5. No herbicides or pesticides are permitted to be used in garden plots. Natural fertilizers are allowed (i.e. compost).
6. Taking produce from other garden plots will result in a loss of gardening privileges for future growing seasons.
7. Water use at the garden is limited to watering plants. The water is not safe to drink. Use of hoses to water a garden plot will result in a loss of gardening privileges. Watering cans or buckets are the recommended means of transporting water to your garden plot.
8. Garden stakes and markings need to remain in place.
9. Keep pathways clear and walkable.
10. All vehicles, unless dropping materials off, must be parked in designated areas only.
11. At the end of the garden season, all plant debris must be removed from the property by you. If you are not able to attend to this you may forfeit your plot for future growing seasons. If, at any time throughout the season, you are caught dumping weeds or plant debris anywhere on park property, you may lose your plot(s).
12. Children are welcome in the garden. To ensure that your children have a great garden experience please supervise them.
13. Repeated use of banned substances, harassment, theft or criminal behavior will be grounds for expulsion. Report any unusual/or unwanted activity to the Town of Menasha Police Department at 920-720-7109. For emergencies, please dial 911.
