**NOTICE OF THE BOARD OF REVIEW
For the Town of Menasha**

NOTICE IS HEREBY GIVEN, the Board of Review will be held on:
WEDNESDAY, SEPTEMBER 10, 2008 - 4 PM TO 6 PM
Municipal Complex-Assembly Rm, 2000 Municipal Dr., Neenah

Please be advised of the following requirements to appear before the Board of Review & procedural requirements if appearing before the Board:

No person shall be allowed to appear before the Board of Review, to testify to the Board by telephone or to contest the amount of any assessment or real or personal property if the person has refused a reasonable written request by certified mail of the assessor to view such property.

All persons wishing to appear before the Board must make an appointment 48 hours prior to the meeting of the Board. **Waivers of the required 48-hour notice of intent to file an objection may be granted during the first two hours for good cause.**

No person scheduled to appear before the Board of Review may contact or provide information to a member of the board about that person's objection except at a session of the Board of Review.

A person who qualifies to appear before the Board may ask for removal of a member of the Board of Review as long as the request is made at least 48 hours before the meeting of the Board (September 8, 2008). This request is to be made to the Clerk of the Board of Review (Karen Backman, 720-7149) and should include the name of the member being removed and the length of time the hearing will take.

Please note: When appearing before the Board the person shall specify in writing the person's estimate of the value of improvement that are the subject of the person's objection & specify the information that the person used to arrive at that estimate.

If a person is objecting to their assessment, which was made by the assessor using the income method, all information must have been provided to the assessor about income & expenses as specified under s. 73.03(2a). If these requirements have not been met, the person will not be allowed to appear before the board, testify by telephone or object to a valuation. Only ill or disabled persons who present to the Board a letter from a physician, surgeon or osteopath that confirm their illness or disability may testify by telephone. No other persons may testify by telephone.

The municipality has provided by ordinance for the confidentiality of information about income & expenses that are provided to the assessor, adopted by the Town Board of Supervisors, & will provide exceptions for persons using the information in the discharge of duties imposed by law or of the duties of their office or by an order of the court. The information that is provided under this paragraph, unless a court determines that it is inaccurate, is not subject to the right of inspection & copying under WI Statute 19.35 (1).
