

**CHAPTER 27**

**NON-METALLIC MINING RECLAMATION**

**PART I - GENERAL**

**27.01 TITLE**

Non-metallic mining reclamation ordinance for the Town of Menasha

**27.02 PURPOSE**

The purpose of this chapter is to establish a local program to ensure the effective reclamation of non-metallic mining sites on which non-metallic mining takes place in Town of Menasha after the effective date of this chapter, in compliance with Chapter NR 135, Wisconsin Administrative Code and Subchapter I of Chapter 295, WI Statutes.

**27.03 STATUTORY AUTHORITY**

This chapter is adopted under authority of Section 295.14(1), WI Statutes, Section NR 135.32, Wisconsin Administrative Code, and Section 60.22, WI Statutes.

**27.04 RESTRICTIONS ADOPTED UNDER OTHER AUTHORITY**

The purpose of this chapter is to adopt and implement the uniform statewide standards for non-metallic mining reclamation required by Section 295.12(1)(a), Stats. and contained in Chapter NR 135, Wisconsin Administrative Code. It is not intended that this chapter repeal, abrogate, annul, impair or interfere with any existing rules, regulation, ordinances or permits not concerning non-metallic mining reclamation previously adopted pursuant to other Wisconsin law. *[Revised 05/07/01]*

**27.05 INTERPRETATION**

In their interpretation and application, the provisions of this chapter shall be held to be the applicable requirements for non-metallic mining reclamation and shall not be deemed a limitation or repeal of any other power granted by the WI Statutes outside the reclamation requirements for non-metallic mining sites required by subchapter I of Chapter 295, WI Statutes and Chapter NR 135, Wisconsin Administrative Code. Where any terms or requirements of this chapter may be inconsistent or conflicting, the more restrictive requirements or interpretation shall apply. Where a provision of this chapter is required by WI Statutes or by a standard in Chapter NR 135, Wisconsin Administrative Code, and where the provision is unclear, the provision shall be interpreted to be consistent with the WI Statutes and the provisions of Chapter NR 135, Wisconsin Administrative Code.

**27.06 SEVERABILITY**

Should any portion of this chapter be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this chapter shall not be affected.

**27.07 APPLICABILITY**

- (1) **Overall Applicability.** The requirements of this chapter apply to all operators of non-metallic mining sites within the Town of Menasha operating on or commencing to operate after August 1<sup>st</sup>, 2001. This chapter does not apply to non-metallic mining sites where non-metallic mining permanently ceases before August 1, 2001. This chapter applies to non-metallic mining conducted by or on behalf of the State of Wisconsin, by or on behalf of a municipality or for the benefit or use of the state or any state agency, board, commission or department, except for the waiver of financial assurance in sub. 14.40.
- (2) **Exemptions.** This chapter does not apply to the following activities:
  - (a) Non-metallic mining at a site or that portion of a site that is subject to permit and reclamation requirements of the Wisconsin Department of Natural Resources under Sec. 30.19, 30.195 or 30.20, Stats. and complies with Chapter NR 340, Wisconsin Administrative Code.
  - (b) Excavations subject to the permit and reclamation requirements of Sec. 30.30 or 30.31, Stats.
  - (c) Excavations or grading by a person solely for domestic or farm use at that person's residence or farm.
  - (d) Excavations or grading conducted for the construction, reconstruction, maintenance or repair of a highway, railroad, airport facility, or any other transportation facility where the excavation or grading is entirely within the property boundaries of the transportation facility.
  - (e) Grading conducted for preparing a construction site or restoring land following a flood or natural disaster.
  - (f) Excavations for building construction purposes conducted on the building site.
  - (g) Non-metallic mining at non-metallic mining sites that affect less than one acre of total area over the life of the mine.
  - (h) Any mining operation, the reclamation of which is required in a permit obtained under Ch. 293, Stats.

- (i) Any activities required to prepare, operate or close a solid waste disposal facility under Ch. 289, Stats., or a hazardous waste disposal facility under Ch. 291, Stats., that are conducted on the property where the facility is located, but an applicable non-metallic mining reclamation ordinance and the standards established in this chapter apply to activities related to solid waste or hazardous waste disposal that are conducted at a non-metallic mining site that is not on the property where the solid waste or hazardous waste disposal facility is located, such as activities to obtain non-metallic minerals to be used for lining, capping, covering or constructing berms, dikes or roads.
- (j) Non-metallic mining conducted to obtain stone, soil, sand or gravel for construction, reconstruction, maintenance or repair of a highway, railroad, airport, or any other transportation facility or part thereof, if the non-metallic mining is subject to the requirements of the Wisconsin Department of Transportation concerning the restoration of the non-metallic mining site.
- (k) This exemption only applies to a non-metallic mining operation with limited purpose and duration where the Wisconsin Department of Transportation actively imposes reclamation requirements and the operator reclaims the non-metallic mining site in accordance with these requirements. The duration of the exemption shall be specific to the length of the Wisconsin Department of Transportation contract for construction of a specific transportation project.
- (l) If a non-metallic mining site covered under pars. (a) and (b) is used to concurrently supply materials for projects unrelated to the Wisconsin Department of Transportation project, the exemption in this paragraph still applies, provided that the site is fully reclaimed under Wisconsin Department of Transportation contract and supervision.
- (m) Dredging for navigational purposes, to construct or maintain farm drainage ditches and for the remediation of environmental contamination and the disposal of spoils from these activities.
- (n) Removal of material from the bed of Lake Michigan or Lake Superior by a public utility pursuant to a permit under s. 30.21, Stats.

## 27.08 ADMINISTRATION

The provisions of this chapter shall be administered by the Community Development Department

## 27.09 EFFECTIVE DATE

The provisions of this chapter shall take effect on June 1, 2001.

## 27.10 DEFINITIONS

In this chapter:

*Alternative requirement:* An alternative to the reclamation standards of this chapter provided through a written authorization granted by the Town of Menasha pursuant to s. 18.

*Applicable reclamation ordinance:* A non-metallic mining reclamation ordinance, including this chapter, that applies to a particular non-metallic mining site and complies with the requirements of this Chapter NR 135, Wisconsin Administrative Code and Subchapter I of Ch. 295, Stats., unless the Wisconsin Department of Natural Resources is the regulatory authority as defined in sub. (20) (b) 3. If the Wisconsin Department of Natural Resources is the regulatory authority, "applicable reclamation ordinance" means the relevant and applicable provisions of Chapter NR 135, Wisconsin Administrative Code.

*Borrow site:* An area outside of a transportation project site from which stone, soil, sand or gravel is excavated for use at the project site, except the term does not include commercial sources.

*Contemporaneous reclamation:* The sequential or progressive reclamation of portions of the non-metallic mining site affected by mining operations that is performed in advance of final site reclamation, but which may or may not be final reclamation, performed to minimize the area exposed to erosion, at any one time, by non-metallic mining activities.

*Department:* Means the Wisconsin Department of Natural Resources.

*Environmental pollution:* Has the meaning in s. 295.11(2), Stats.

*Existing mine:* A non-metallic mine where non-metallic mining takes place before August 1, 2001.

*Financial assurance:* A commitment of funds or resources by an operator to a regulatory authority that satisfies the requirements in s. 14 and is sufficient to pay for reclamation activities required by this chapter.

*Landowner:* The person who has title to land in fee simple or who holds a land contract for the land. A landowner is not a person who owns non-metallic mineral rights to land, if a different person possesses title to that land in fee simple or holds a land contract for that land.

*Municipality:* Means any city, town or village.

*Non-metallic mineral:* A product, commodity or material consisting principally of naturally occurring, organic or inorganic, non-metallic, nonrenewable material. Non-metallic minerals include, but are not limited to, stone, sand, gravel, asbestos, beryl, diamond, clay, coal, feldspar, peat, talc and topsoil.

*Non-metallic mining or mining:* Means all of following:

- (a) Operations or activities at a non-metallic mining site for the extraction from the earth of mineral aggregates or non-metallic minerals for sale or use by the operator. Non-metallic mining includes use of mining equipment or techniques to remove materials from the in-place non-metallic mineral deposit, including drilling and blasting, as well as associated activities such as excavation, grading and dredging. Non-metallic mining does not include removal from the earth of products or commodities that contain only minor or incidental amounts of non-metallic minerals, such as commercial sod, agricultural crops, ornamental or garden plants, forest products, Christmas trees or plant nursery stock.
- (b) Processes carried out at a non-metallic mining site that is related to the preparation or processing of the mineral aggregates or non-metallic minerals obtained from the non-metallic mining site. These processes include, but are not limited to stockpiling of materials, blending mineral aggregates or non-metallic minerals with other mineral aggregates or non-metallic minerals, blasting, grading, crushing, screening, scalping and dewatering.

*Non-metallic mining reclamation or reclamation:* The rehabilitation of a non-metallic mining site to achieve a land use specified in a non-metallic mining reclamation plan approved under this chapter, including removal or reuse of non-metallic mining refuse, grading of the non-metallic mining site, removal, storage and replacement of topsoil, stabilization of soil conditions, reestablishment of vegetative cover, control of surface water and groundwater, prevention of environmental pollution and, if practicable, the restoration of plant, fish and wildlife habitat.

*Non-metallic mining refuse:* Means waste soil, rock and mineral, as well as other natural site material resulting from non-metallic mining. Non-metallic mining refuse does not include marketable by-products resulting directly from or displaced by the non-metallic mining that are scheduled to be removed from the non-metallic mining site within a reasonable period of time after extraction.

*Non-metallic mining site or site:* All contiguous areas of present or proposed mining described in par. (a), subject to the qualifications in par. (b).

- (a) Non-metallic mining site means the following:
  - (1) The location where non-metallic mining is proposed or conducted.

- (2) Storage and processing areas that are in or contiguous to areas excavated for non-metallic mining.
- (3) Areas where non-metallic mining refuse is deposited.
- (4) Areas affected by activities such as the construction or improvement of private roads or haulage ways for non-metallic mining.
- (5) Areas where grading or re-grading is necessary.
- (6) Areas where non-metallic mining reclamation activities are carried out or structures needed for non-metallic mining reclamation, such as topsoil stockpile areas, re-vegetation test plots, or channels for surface water diversion, are located.
- (b) Non-metallic mine site does not include any of the following areas:
  - (1) Those portions of sites listed in par. (a) not used for non-metallic mining or purposes related to non-metallic mining after August 1, 2001.
  - (2) Separate, previously mined areas that are not used for non-metallic mineral extraction after August 1, 2001 and are not contiguous to mine sites, including separate areas that are connected to active mine sites by public or private roads.
  - (3) Areas previously mined but used after August 1, 2001 for a non-mining activity, such as stockpiles of materials used for an industrial process unrelated to non-metallic mining.

*Operator:* Any person who is engaged in, or who has applied for a permit to engage in, non-metallic mining, whether individually, jointly or through subsidiaries, agents, employees, contractors or subcontractors.

*Registered geologist:* A person who is registered as a professional geologist pursuant to ss. 443.037 and 443.09, Stats.

*Registered professional engineer:* A person who is registered as a professional engineer pursuant to ss. 443.04 and 443.09, Stats.

*Regulatory authority* means the following:

- (a) The Town of Menasha for non-metallic mine sites located within its jurisdiction, or
- (b)
  - (1) A municipality in which the non-metallic mining site is located and which has adopted an applicable reclamation ordinance,

- (2) The county in which the non-metallic mining site is located, if no reclamation municipal ordinance exists pursuant to subd. 1., provided the county has an applicable reclamation ordinance, or
- (3) The Wisconsin Department of Natural Resources, but only if there is no applicable reclamation ordinance enacted by the municipality or the county in which the non-metallic mining site is located.

*Replacement of topsoil:* The replacement or redistribution of topsoil or topsoil substitute material to all areas where topsoil was actually removed or affected by non-metallic mining for the purposes of providing adequate vegetative cover and stabilization of soil conditions needed to achieve the approved post-mining land use and as required by the reclamation plan approved pursuant to this chapter. [Revised 05/07/01]

*Solid waste:* Any garbage, refuse, sludge from a waste treatment plant, water supply treatment plant or air pollution control facility and other discarded or salvageable materials, including solid, liquid, semisolid or contained gaseous materials resulting from industrial, commercial, mining and agricultural operations, and from community activities, but does not include solids or dissolved material in domestic sewage, or solid or dissolved materials in irrigation return flows or industrial discharges which are point sources subject to permits under ch. 283, Stats., or source material, special nuclear material or by-product material, as defined in s. 254.31 (1), Stats.

*Topsoil:* The surface layer of soil which is generally more fertile than the underlying soil layers, which is the natural medium for plant growth and which can provide the plant growth, soil stability and other attributes necessary to meet the success standards approved in the reclamation plan.

*Topsoil substitute material:* Soil or other unconsolidated material either used alone or mixed with other beneficial materials and which can provide the plant growth, site stability and other attributes necessary to meet the success standards approved in the reclamation plan.

*Unreclaimed acre or unreclaimed acres:* Those unreclaimed areas in which non-metallic mining has occurred after August 1, 2001, and areas where non-metallic mining reclamation has been completed but is not yet certified as reclaimed under sub. 29.30. However the term does not include any areas described in par. (b).

- (a) *Unreclaimed acre or unreclaimed acres* does not include:
  - (1) Those areas where reclamation has been completed and certified as reclaimed under sub. 29.30.
  - (2) Those areas previously affected by non-metallic mining but which are not used for non-metallic mining after August 1, 2001.

- (3) Those portions of non-metallic mining sites, which are included in a non-metallic mining reclamation, plan approved pursuant to this chapter, but, is not yet affected by non-metallic mining.
- (4) Areas previously mined but used after August 1, 2001 for a non-mining activity, such as stockpiling of materials used for an industrial activity such as an asphalt plant, concrete batch plant, block and tile operation or other industry that uses products produced from non-metallic mining.
- (5) For purposes of fees under s. 27, those areas within a non-metallic mining site which the Town of Menasha has determined to have been successfully reclaimed on an interim basis in accordance with Section 27.29(3). [Revised 05/07/01]

**PART II – STANDARDS**

reclamation may not adversely affect neighboring properties.

**27.11 STANDARDS**

- (1) All non-metallic mining sites subject to this chapter shall be reclaimed in conformance with the standards contained below.
- (2) **General standards**
  - (a) **Refuse and Other Solid Wastes.** Non-metallic mining refuse shall be reused in accordance with a reclamation plan. Other solid wastes shall be disposed of in accordance with applicable rules of the Wisconsin Department of Natural Resources adopted pursuant to Ch. 289 and 291, Stats.
  - (b) **Area Disturbed and Contemporaneous Reclamation.** Non-metallic mining reclamation shall be conducted, to the extent practicable, to minimize the area disturbed by non-metallic mining and to provide for non-metallic mining reclamation of portions of the non-metallic mining site while non-metallic mining continues on other portions of the non-metallic mining site.
  - (c) **Public Health, Safety and Welfare.** All non-metallic mining sites shall be reclaimed in a manner so as to comply with federal, state and local regulations governing public health, safety and welfare.
  - (d) **Habitat Restoration.** When the land use required by the reclamation plan approved pursuant to this chapter requires plant, fish or wildlife habitat, it shall be restored, to the extent practicable, to a condition at least as suitable as that, which existed before the lands were affected by non-metallic mining operations.
  - (e) **Compliance with Environmental Regulations.** Reclamation of non-metallic mining sites shall comply with any other applicable federal, state and local laws including those related to environmental protection, zoning and land use control.
- (3) **Surface Water and Wetlands Protection.** Non-metallic mining reclamation shall be conducted and completed in a manner that assures compliance with the Wisconsin Department of Natural Resources' water quality standards for surface waters and wetlands contained in Chapters NR 102 to NR 105, Wisconsin Administrative Code. Before disturbing the surface of a non-metallic mining site and removing topsoil, all necessary measures for diversion and drainage of runoff from the site to prevent pollution of waters of the state shall be installed in accordance with the reclamation plans approved pursuant to this chapter. Diverted or channelized runoff resulting from

**(4) Groundwater Protection**

- (a) **Groundwater Quantity.** A non-metallic mining site shall be reclaimed in a manner that does not cause a permanent lowering of the water table that result in adverse effects on surface waters or a significant reduction in the quantity of groundwater reasonably available for future users of groundwater.
- (b) **Groundwater Quality.** Non-metallic mining reclamation shall be conducted in a manner, which does not cause groundwater quality standards in Chapter NR 140, Wisconsin Administrative Code to be exceeded at a point of standards application defined in that chapter.

**(5) Topsoil Management**

- (a) **Removal.** Topsoil and topsoil substitute material shall be removed, protected and redistributed to support reclamation and site stabilization. Topsoil shall be managed as specified in the reclamation plan approved pursuant to this chapter in order to achieve reclamation to the approved post-mining land use. Topsoil and topsoil substitute material removal shall be performed, as required by the reclamation plan, prior to any mining activity associated with any specific phase of the mining operation.
- (b) **Volume.** The operator shall obtain the volume of soil required to perform final reclamation by removal of on-site topsoil or topsoil substitute material or by obtaining topsoil or substitute material as needed to make up the volume of topsoil as specified in the reclamation plan approved pursuant to this chapter.
- (c) **Storage.** Once removed, topsoil or topsoil substitute material shall, as required by the reclamation plan approved pursuant to this chapter, either be used in contemporaneous reclamation or stored in an environmentally acceptable manner. The location of stockpiled topsoil or topsoil substitute material shall be chosen to protect the material from erosion or further disturbance or contamination. Runoff water shall be diverted around all locations in which topsoil or topsoil substitute material is stockpiled.

(6) **Final Grading and Slopes.**

- (a) All areas affected by mining shall be graded in accordance with the reclamation plan approved pursuant to this chapter to achieve a stable and safe condition consistent with the post mining land use. The reclamation plan may designate areas such as stable slopes and rock faces which do not require final grading.
- (b) Final reclaimed slopes covered by topsoil or topsoil substitute material may not be steeper than a 3:1 horizontal to vertical incline, unless alternative requirements are approved under s. 18, and stable slopes can be demonstrated based on site-specific engineering analysis. The engineering analysis shall show that a minimum acceptable slope stability factor is attainable at a steeper slope and that the post-mining land use specified in the reclamation plan is not adversely affected. When the slope occurs at the edge of a body of water, this approved slope shall extend vertically 6 feet below the lowest seasonal water level. A slope no steeper than 3:1 shall be created at a designated location or locations, depending on the size of the water body to allow for a safe exit.
- (c) All areas in the non-metallic mine site where topsoil or topsoil substitute material is to be reapplied shall be graded or otherwise prepared prior to topsoil or topsoil substitute material redistribution to provide the optimum adherence between the topsoil or topsoil substitute material and the underlying material.

(7) **Topsoil Redistribution for Reclamation.** Topsoil or topsoil substitute material shall be redistributed in accordance with the reclamation plan approved pursuant to this chapter in a manner, which minimizes compaction and prevents erosion. Topsoil or topsoil substitute material shall be uniformly redistributed except where uniform redistribution is undesirable or impractical. Topsoil or topsoil substitute material redistribution may not be performed during or immediately after a precipitation event until the soils have sufficiently dried.

(8) **Re-vegetation and Site Stabilization.** Except for permanent roads or similar surfaces identified in the reclamation plan approved pursuant to this chapter, all surfaces affected by non-metallic mining shall be reclaimed and stabilized by re-vegetation or other means. Re-vegetation and site stabilization shall be in accordance with the approved reclamation plan and shall be performed as soon as practicable after mining activity has permanently ceased in any part of the mine site.

(9) **Assessing Completion of Successful Reclamation**

- (a) The criteria for assessing when reclamation is complete and, therefore, when the financial

assurance may be released shall be specified in the reclamation plan approved pursuant to this chapter. Criteria to evaluate reclamation success shall be quantifiable.

(b) Compliance with the re-vegetation success standards in the approved reclamation plan shall be determined by:

- (1) On-site inspections by the Town of Menasha or its agent;
- (2) Reports presenting results obtained during reclamation evaluations including summarized data on re-vegetation, photo documentation or other evidence that the criteria approved in the reclamation plan to ascertain success have been met; or
- (3) A combination of inspections and reports.

(a) In those cases where the post mining land use specified in the reclamation plan requires a return of the mining site to a pre-mining condition, the operator shall obtain baseline data on the existing plant community for use in the evaluation of reclamation success pursuant to this section.

(b) Re-vegetation success may be determined by:

- (1) Comparison to an appropriate reference area;
- (2) Comparison to baseline data acquired at the mining site prior to its being affected by mining; or
- (3) Comparison to an approved alternate technical standard.

(c) Re-vegetation using a variety of plants indigenous to the area is favored.

(10) **Intermittent Mining.** Intermittent mining may be conducted provided that the possibility of intermittent cessation of operations is addressed in an operator's reclamation permit, no environmental pollution or erosion of sediments is occurring, and financial assurance for reclamation pursuant to s. 14 is maintained covering all remaining portions of the site that have been affected by non-metallic mining and that have not been reclaimed.

- (11) **Maintenance.** During the period of the site reclamation, after the operator has stated that reclamation is complete but prior to release of financial assurance, the operator shall perform any maintenance necessary to prevent erosion, sedimentation or environmental pollution, comply with the standards of this subchapter, or to meet the goals specified in the reclamation plan approved pursuant to this chapter.

**PART III - PERMITTING**

**27.12 NON-METALLIC MINING RECLAMATION PERMIT APPLICATION**

- (1) **Required Submittal.** All operators of non-metallic mining sites that operate on or after August 1, 2001 shall apply for a reclamation permit from Town of Menasha. All applications for reclamation permits under this section shall be accompanied by the following information:

- (a) A brief description of the general location and nature of the non-metallic mine
- (b) A legal description of the property on which the non-metallic mine is located or proposed, including the parcel identification number
- (c) The names, addresses and telephone numbers of all persons or organizations who are owners or lessors of the property on which the non-metallic mining site is located
- (d) The name, address and telephone number of the person or organization who is the operator
- (e) A certification by the operator of his or her intent to comply with the statewide non-metallic mining reclamation standards established by Part II.

- (2) **Existing Mines.** The operator of any existing non-metallic mining site in operation on August 1, 2001 may apply for an automatic reclamation permit from the Town of Menasha by providing the information set forth below no later than on August 1, 2001 to the Town of Menasha Community Development Department, 2000 Municipal Drive, Neenah, WI 54956, by mail or other means determined acceptable by the Town of Menasha.

- (a) The information required by sub. 12.10.
- (b) The first year's annual fee, as required by s. 27.
- (c) A certification signed by the operator that he or she will provide the Town of Menasha with a complete reclamation plan required by s. 13 and financial assurance required by s. 14 no later than the times established pursuant to this chapter.

- (3) **New Mines.** The operator of any non-metallic mine site that engages in or plans to engage in non-metallic mining that will begin operations after August 1<sup>st</sup>, 2001 or which has not applied for an automatic reclamation permit pursuant to sub. 12.20 shall submit an application that meets the requirements specified below to the Town of Menasha Community Development Department at 2000 Municipal Drive, Neenah, WI 54956 by mail or other means determined acceptable by the Town of Menasha prior to beginning operations. A plan review fee as specified in s. 26 shall accompany this application.

- (a) The information required by sub. 12.10.
- (b) The plan review and annual fees required by secs. 26 and 27.
- (c) A reclamation plan conforming to s. 13.
- (d) A certification that the operator will provide, as a condition of the reclamation permit, provide financial assurance as required by s. 14 upon granting of the reclamation permit and before mining begins.
- (e) To avoid duplication, the permit application and submittals required under this subsection may, by reference, incorporate existing plans or materials that meet the requirements of this chapter.

**27.13 RECLAMATION PLAN**

- (1) **Reclamation Plan Requirements.** All operators of non-metallic mining sites subject to this chapter shall prepare and submit a reclamation plan that meets the following requirements.

- (a) **Plan Required.** An operator who conducts or plans to conduct non-metallic mining on or after August 1<sup>st</sup>, 2001 shall submit to the Town of Menasha reclamation plan that meets the requirements of this section and complies with the standards of Part II. To avoid duplication, the reclamation plan may, by reference, incorporate existing plans or materials that meet the requirements of this chapter.
- (b) **Site Information.** The reclamation plan shall include information sufficient to describe the existing natural and physical conditions of the site, including, but not limited to:

- (1) Maps of the non-metallic mining site including the general location, property boundaries, the aerial extent, geologic composition and depth of the non-metallic mineral deposit, the distribution, thickness and type of topsoil, the approximate elevation of ground water, the location of surface waters and the existing drainage patterns.
- (2) Information available to the mine operator on biological resources, plant communities, and wildlife use at and adjacent to the proposed or operating mine site.
- (3) Existing topography as shown on contour maps of the site at 2-foot contour intervals.
- (4) Location of manmade features on or near the site.
- (5) For existing mines, a plan view drawing showing the location and extent of land previously affected by non-metallic mining, including the location of stockpiles, wash ponds and sediment basins.

(c) **Post-Mining Land Use.**

- (1) The reclamation plan shall specify a proposed post-mining land use for the non-metallic mine site. The proposed post-mining land use shall be consistent with local land use plans and local zoning at the time the plan is submitted, unless a change to the land use plan or zoning is proposed. The proposed post-mining land use shall also be consistent with all applicable local, state, or federal laws in effect at the time the plan is submitted.
- (2) Land used for non-metallic mineral extraction in areas zoned under an exclusive agricultural use ordinance pursuant to s. 91.75, Stats. shall be restored to agricultural use.
- (3) Reclamation Measures. The reclamation plan shall include a description of the proposed reclamation, including methods and procedures to be used and a proposed schedule and sequence for the completion of reclamation activities for various stages of reclamation of the non-metallic mining site. The following shall be included:
  - (a) A description of the proposed earthwork and reclamation, including final slope angles, high wall reduction, benching, terracing and other structural slope stabilization measures.
  - (b) The methods of topsoil or topsoil substitute material removal, storage, stabilization and conservation that will be used during reclamation.

- (c) A plan or map which shows anticipated topography of the reclaimed site and any water impoundments or artificial lakes needed to support the anticipated future land use of the site.
  - (d) A plan or map which shows surface structures, roads and related facilities after the cessation of mining.
  - (e) The estimated cost of reclamation for each stage of the project or the entire site if reclamation staging is not planned.
  - (f) A re-vegetation plan, which shall include timing and methods of seedbed preparation, rates and kinds of soil amendments, seed application timing, methods and rates, mulching, netting and any other techniques needed to accomplish soil and slope stabilization.
  - (g) Quantifiable standards for re-vegetation adequate to show that a sustainable stand of vegetation has been established which will support the approved post-mining land use. Standards for re-vegetation may be based on the percent vegetative cover, productivity, plant density, diversity or other applicable measures.
  - (h) A plan and, if necessary, a narrative showing erosion control measures to be employed during reclamation activities. These shall address how reclamation activities will be conducted to minimize erosion and pollution of surface and groundwater.
  - (i) A description of any areas which will be reclaimed on an interim basis sufficient to qualify for the waiver of fees pursuant to subs. 29.20 and 29.40 if the regulatory authority decides to release financial assurance for such areas pursuant to sub. 29.40(3) as authorized by s. NR 135.42155.41(4), Wisconsin Administrative Code and release of financial assurance pursuant to sub. 29.30(3) and, which will be subsequently disturbed prior to final reclamation. Descriptions shall include an identification of the proposed areas involved, methods of reclamation to comply with the standards in Part II and timing of interim and final reclamation. [revised 05/07/01]
- (4) The reclamation plan shall contain criteria for assuring successful reclamation in accordance s. 11 (8).

- (5) **Certification of Reclamation Plan.**
- (a) The operator shall provide a signed certification that reclamation will be carried out in accordance with the reclamation plan. The landowner and lessee, if different from the operator, shall also provide signed certification that they concur with the reclamation plan and will allow its implementation, except as provided in par. (b).
- (b) For the following situations, the landowner and lessee, if different from the mine operator, are not required to submit a written certification in accordance with par. (a). The operator shall provide written evidence that the landowner and lessee, if different from the operator, have been provided with a written copy of the reclamation plan, and that:
- (1) The mine operator has submitted a reclamation plan for an existing mine in accordance with sub. 12.20, or
  - (2) The operator has submitted a reclamation plan for a new or reopened mine in accordance sub. 12.30, which is located on land for which a lease agreement or memorandum of lease between the landowner and applicant was recorded prior August 1<sup>st</sup>, 2001.
- (6) **Approval.** The operator shall keep a copy of the reclamation plan required by this section, once approved by the Town of Menasha under this chapter, at the mine site or, if not practicable, at the operator's nearest office or place of business.
- (d) **Existing Mines.** The operator of any non-metallic mining site that submits an automatic permit application in conformance with sub. 12.20 shall submit the reclamation plan required by sub. 13.10 by within one year after receipt of the automatic permit under sub 16.20 unless the Town of Menasha extends such deadline. All requests for extensions shall include an explanation a justification for the extension. The maximum length of an extension shall be no more than two years.
- (e) **New Mines.** The operator of any non-metallic mining site not in operation prior to August 1, 2001 that applies for a permit in conformance with sub. 12.30 shall submit the reclamation plan required by sub. 13.10 with its application for a reclamation permit.
- (f) **Existing Plans and Approvals.** To avoid duplication of effort, the reclamation plan required by sub. 13.10 may, by reference, incorporate existing plans or materials that meet the requirements of this chapter. Previous approvals for non-metallic mining sites in operation on August 1<sup>st</sup>, 2001 shall satisfy the requirements of sub. 13.10 if they meet the following requirements:
- (1) The document has been approved by a county or municipality; and
  - (2) The Town of Menasha finds that the document designates a post-mining land use and describes reclamation measures that meet the reclamation standards of this chapter.
- (g) **Approval of Reclamation Plan.** The Town of Menasha shall approve, conditionally approve or deny the reclamation plan submitted under this section in writing in accordance with sub. 16.30(3) for existing mines and sub. 16.40 for mines that apply for reclamation permit in conformance with sub. 12.30. Conditional approvals of reclamation plans shall be made according to sub. 16.70 and denials of reclamation plans shall be made pursuant to s. 17. The operator shall keep a copy of the reclamation plan approved under this subsection at the mine site or, if not practicable, at the operator's nearest place of business.

## 27.14 FINANCIAL ASSURANCE

(1) Financial Assurance Requirements. All operators of non-metallic mining sites in the Town of Menasha shall prepare and submit a proof of financial assurance that meets the following requirements:

- (a) **Notification.** The regulatory authority shall provide written notification to the operator of the amount of financial assurance required under sub. (3).
- (b) **Filing.** Following approval of the non-metallic mining reclamation permit, and as a condition of the permit, the operator shall file a financial assurance with in the Town of Menasha. The financial assurance shall provide that the operator shall faithfully perform all requirements in this chapter, an applicable reclamation ordinance and the reclamation plan. Financial assurance shall be payable exclusively to the Town of Menasha. In cases where one or more other regulatory authorities regulate a non-metallic mining site, all financial assurance shall be made payable to the Town of Menasha only if it currently has primary regulatory responsibility.
- (c) **Amount and Duration of Financial Assurance.** The amount of financial assurance shall equal as closely as possible the cost to the Town of Menasha of hiring a contractor to complete either final reclamation or progressive reclamation according to the approved reclamation plan. The amount of financial assurance shall be reviewed periodically by the Town of Menasha to assure it equals outstanding reclamation costs. Any financial assurance filed with the Town of Menasha shall be in an amount equal to the estimated cost for reclaiming all sites the operator has under project permits. The Town of Menasha may accept a lesser initial amount of financial assurance provided that the permittee initiates a process to continuously increase the amount of financial assurance until it is adequate to affect reclamation. An escrow account may be established that is based on production gross sales and serves to provide regular payments to an account that is designed to grow to the amount necessary to guarantee performance of reclamation by the expected time of final reclamation. The period of the financial assurance is dictated by the period of time required to establish the post mining land use declared and approved of in the reclamation plan. This may extend beyond the permit if required to accomplish successful and complete implementation of the reclamation plan.
- (d) **Form and Management.** Financial assurance shall be provided by the operator and shall be by a bond or an alternate financial assurance. Financial assurance shall be payable to the Town

of Menasha and released upon successful completion of the reclamation measures specified in the reclamation plan. Alternate financial assurances may include, but are not limited to cash, certificates of deposits, irrevocable letters of credit, irrevocable trusts, established escrow accounts, demonstration of financial responsibility by meeting net worth requirements, or government securities. Any interest from the financial assurance shall be paid to the operator. Certificates of deposit shall be automatically renewable or other assurances shall be provided before the maturity date. Financial assurance arrangements may include, at the discretion of the Town of Menasha, a blend of different options for financial assurance including a lien on the property on which the non-metallic mining site occurs or a combination of financial assurance methods.

- (e) **Multiple Projects.** Any operator who obtains a permit from the Town of Menasha for 2 or more non-metallic mining sites may elect, at the time the second or subsequent site is approved, to post a single financial assurance in lieu of separate financial assurance instruments for each non-metallic mining site. When an operator elects to post a single financial assurance in lieu of separate financial assurances for each mining site, no financial assurances previously posted on individual mining sites shall be released until the Town of Menasha has accepted the new financial assurance.
- (f) **Multiple Jurisdictions.** In cases where more than one regulatory authority has jurisdiction, a cooperative financial security arrangement may be developed and implemented by the regulatory authorities to avoid requiring the permittee to prove financial assurance with more than one regulatory authority for the same non-metallic mining site. Financial assurance is required for each site and two or more sites of less than one acre by the same operator, except that governmental units are not required to obtain financial assurance.
- (g) **Certification of Completion and Release.**
  - (1) The operator shall notify the regulatory authority, by filing a notice of completion, at the time that he or she determines that reclamation of any portion of the mining site or the entire site is complete. The Town of Menasha shall inspect the mine site or portion thereof that was the subject of the notice of completion to determine if reclamation has been carried out in accordance with the approved reclamation plan. The Town of Menasha may partially release the financial assurance if it determines that compliance with a portion of the reclamation plan has been achieved and

requires no waiting period. After determining that reclamation is complete, the Town of Menasha shall issue a certificate of completion and shall release the financial assurance or appropriately reduce the financial assurance in the case of reclamation of a portion of the mining site.

- (2) The Town of Menasha shall make a determination of whether or not the certification in par. (a) can be made within 60 days that the request is received.
- (3) The Town of Menasha may make a determination under this subsection that:
  - (a) Reclamation is not yet complete;
  - (b) It is not possible to assess whether reclamation is complete due to weather conditions, snow cover or other relevant factors;
  - (c) Reclamation is complete in a part of the mine; or
  - (d) Reclamation is fully complete.
- (h) **Forfeiture.** Financial assurance shall be forfeited if any of the following occur:
  - (1) A permit is revoked under s. 24 and the appeals process has been completed.
  - (2) An operator ceases mining operations and fails to reclaim the site in accordance with the reclamation plan.
  - (3) Cancellation. Financial assurance shall provide that it may not be cancelled by the surety or other holder or issuer, except after not less than a 90-day notice to the Town of Menasha in writing by registered or certified mail. Not less than 30 days prior to the expiration of the 90-day Notice of Cancellation, the operator shall deliver to the Town of Menasha a replacement proof of financial assurance. In the absence of this replacement financial assurance, all mining shall cease until the time it is delivered and in effect.
  - (4) Changing Methods Of Financial Assurance. The operator of a non-metallic mining site may change from one method of financial assurance to another. This may not be done more than once a year unless required by an adjustment imposed pursuant to sub. (12). The operator shall give the Town of Menasha at least 60 days notice prior to changing methods of financial assurance and may not actually change methods without the written approval of the Town of Menasha.
  - (5) Bankruptcy Notification. The operator of a non-metallic mining site shall notify the

regulatory authority by certified mail of the commencement of voluntary or involuntary proceeding under bankruptcy code, 11 USC, et seq., naming the operator as debtor, within 10 days of commencement of the proceeding.

- (6) **Adjustment of Financial Assurance.** Financial assurance may be adjusted when required by the Town of Menasha. The Town of Menasha may notify the operator in writing that adjustment is necessary and the reasons for it. The Town of Menasha may adjust financial assurance based upon prevailing or projected interest or inflation rates, or the latest cost estimates for reclamation.
- (7) **Net Worth Test.**
  - (a) Only an operator that meets the definition of "company" in s. 289.41 (1) (b), Stats., may use the net worth method of providing financial assurance.
  - (b) The operator shall submit information to the regulatory authority in satisfaction of the net worth test requirements of s. 289.41 (4), Stats. The criteria in Secs. 289.41 (6) (b), (d), (e), (f), (g), (h) and (i), Stats. shall apply.
  - (c) An operator using the net worth test to provide financial assurance for more than one mine shall use the total cost of compliance for all mines in determining the net worth to reclamation cost ratio in accordance with s. 289.41 (6), Stats.
  - (d) Determinations under the net worth test shall be done in accordance with s. 289.41 (5), Stats.
  - (e) In addition, the operator shall submit a legally binding commitment to faithfully perform all compliance and reclamation work at the mine site that is required under this chapter.
- (2) **Existing Mines.** The operator of any non-metallic mining site that applies for an automatic reclamation permit in conformance with sub. 12.20, shall submit the proof of financial assurance required by sub. 14.10 no later than one year after receipt of the automatic permit under sub. 16.20 unless a formal request stating the reasons for an extension is requested by the operator and is granted by the Town of Menasha. All extensions, if granted shall be no more than two years after the normal requirement of one year.
- (a) **New Mines.** The operator of any non-metallic mining site that applies for a reclamation permit in conformance with s. 12.30 shall submit the proof of financial assurance required by sub. 14.10 as specified in the reclamation permit issued to it under this chapter.

- (b) **Public Non-metallic Mining.** The financial assurance requirements of this section do not apply to non-metallic mining conducted by the State of Wisconsin, a state agency, board, commission or department, or a municipality.

**27.15 PUBLIC NOTICE AND RIGHT OF HEARING**

- (1) **New Mines.** The Town of Menasha shall, except as provided in sub 15.20, provide public notice and the opportunity for a public informational hearing as set forth below:

- (a) **Public Notice.**

- (1) Except as provided in sub. (3) for existing mines, when the Town of Menasha receives a complete application to issue a reclamation permit, it shall publish a public notice of the application no later than 30 days after receipt of a complete application that satisfies sub. 12.30. *[Revised 05/07/01]*
- (2) The notice shall briefly describe the mining and reclamation planned at the non-metallic mining site. The notice shall be published as a class 2 notice pursuant to s. 985.07(2), Stats., in the official newspaper of the Town of Menasha. The notice shall mention the opportunity for public hearing pursuant to this section and shall give the locations at which the public may review the application and all supporting materials including the reclamation plan.
- (3) Copies of the notice shall be forwarded by the Town of Menasha to the county or applicable local zoning board, the county and applicable local planning organization, the county land conservation officer, and owners of land within 300 feet of the boundaries of the parcel or parcels of land on which the site is located.

- (b) **Hearing.** Except as provided in sub. (3) for existing mines, the Town of Menasha shall provide for an opportunity for a public informational hearing on an application or request to issue a non-metallic mining reclamation permit as follows:

- (1) If it conducts a zoning-related hearing on the non-metallic mine site, the Town of Menasha shall provide the opportunity at this hearing to present testimony on reclamation-related matters. This opportunity shall fulfill the requirement for public hearing for a non-metallic mining reclamation permit required by this section. The Town of Menasha shall consider the reclamation-related testimony in the zoning-

related hearing in deciding on a permit application pursuant to this chapter.

- (2)

- (a) If there is no opportunity for a zoning-related hearing on the non-metallic mine site as described in par. (a), opportunity for public hearing required by this section shall be provided as follows. Any person residing within, owning property within, or whose principal place of business is within 300 feet of the boundary of the parcel or parcels of land in which the non-metallic mining site is located or proposed may request a public informational hearing. The Town of Menasha shall hold a public hearing if requested by any of these persons within 30 days of the actual date of public notice under sub. (1). This public informational hearing shall be held no sooner than 30 days nor later than 60 days after being requested. The hearing shall be conducted as an informational hearing for the purpose of explaining and receiving comment from affected persons on the nature, feasibility and effects of the proposed reclamation. Information on the proposed non-metallic mining reclamation permit shall be provided at the meeting including plans showing the future reclamation of the site. All individuals in attendance at this meeting shall be given the opportunity to comment on the plan. The hearing officer shall be given the authority to limit comments that are determined repetitive or do not relate to the reclamation plan.

- (b) The subject matter and testimony at this informational hearing shall be limited to reclamation of the non-metallic mine site.

- (2) **Existing Mines**

- (a) No public notice or informational hearing is required for a non-metallic mining reclamation permit issued pursuant to sub. 16.20 for an existing mine, except as provided in sub. (3).
- (b) If the regulatory authority accepts a previously approved reclamation plan for that mine as provided in sub. 16.30(2)(a), no further public notice or informational hearing is required.

(c) If the Town of Menasha requires the submittal of a new reclamation plan, public notice and the opportunity for public informational hearing shall be provided following the receipt of the reclamation plan in accordance sub. 15.10. In this case, the subject matter and testimony at that hearing, if held, shall be limited to the new reclamation plan.

(3) **Local Transportation-Related Mines.** No public notice or informational hearing is required for a non-metallic mining reclamation permit issued to a local transportation-related mine pursuant to sub. 16.50.

**27.16 ISSUANCE OF A NON-METALLIC MINING RECLAMATION PERMIT**

(1) **Permit Required.** Every operator of a non-metallic mining site in the Town of Menasha who engages in or plans to engage in non-metallic mining after September 1<sup>st</sup>, 2001 shall obtain a reclamation permit issued under this section, except for non-metallic mining sites that are exempt from this chapter under sub. 7.20. No person may engage in non-metallic mining or non-metallic mining reclamation after September 1<sup>st</sup>, 2001 without a reclamation permit issued pursuant to this chapter.

(2) **Automatic Permit for Existing Mines.** The Town of Menasha shall issue an automatic reclamation permit to the operator of a non-metallic mining site that submits an application meeting the requirements of sub. 12.20, according to the following provisions:

(a) The permit shall be issued within 30 days of such application.

(b) Existing mines that are granted a reclamation permit pursuant to this subsection shall, within one (1) year of the receipt of the permit or as other deadline as determined by the Town of Menasha as established in subs. 13.20 and 14.20, submit to the Town of Menasha the following:

(1) A reclamation plan that meets the requirements of s. 13; and

(2) Financial assurance required pursuant to s. 14.

(c) The Town of Menasha may grant a reasonable extension to the deadline in sub. (2), when it finds extenuating circumstances exist.

(3) **Evaluation of Follow-Up Submittals for Existing Mines.**

Mines covered by automatic permits issued under sub. 27.16(b) shall submit a reclamation plan as required in section 27.16(b)(2). The Town of Menasha where extenuating circumstances exist may grant reasonable extensions to these deadlines in writing. These

follow-up submittals shall be evaluated as set forth below: *[revised 05/07/01]*

(a) The reclamation plan and financial assurance shall meet the requirements of sub. 16.20(2).

(b)

(1) The Town of Menasha shall accept, as satisfaction of the requirement for submittal of a reclamation plan pursuant to sub. 16.20(2)(a), submittal of a previously-completed document that includes plans for reclamation so long as:

(a) The document has been approved by a county or municipality; and

(b) The Town of Menasha finds that the document designates a post-mining land use and describes reclamation measures that meet the reclamation standards of this chapter.

(2) If the Town of Menasha determines that a document with reclamation plans previously approved meets some, but not all of, the requirements of this chapter, it shall request the supplemental information needed to satisfy the reclamation plan requirements of this section. In that case, the Town of Menasha shall determine whether or not to provide public notice and opportunity for public hearing pursuant to sub. 15.20(3), depending on the nature and extent of the supplemental information.

(c) Within 30 days of receipt of the reclamation plan and evidence of financial assurance as required under sub. 16.20(2), the Town of Menasha shall affirm in writing its decision whether to approve these submittals and continue the non-metallic mining reclamation permit issued pursuant to sub. 16.20. A reclamation permit with this written affirmation shall satisfy the requirements of this chapter without further action, submittal or approval.

(4) **Permit Issuance for New Mines.** Applications for reclamation permits for non-metallic mining sites not in operation on August 1<sup>st</sup>, 2001 that satisfy s. 12.30 shall be issued a reclamation permit or otherwise acted on as provided below.

(a) Unless denied pursuant to s. 17, the Town of Menasha shall approve in writing a request that satisfies the requirements of sub. 12.30 to issue a non-metallic mining reclamation permit for a non-metallic mine where mining has not yet taken place before August 1, 2001 or an existing non-metallic mine where mining is not taking place on or after August 1, 2001. *[Revised 05/07/01]*

- (b) The Town of Menasha may not issue an approval without prior or concurrent approval of the reclamation plan that meets the requirements of s. 13. The regulatory authority may issue a reclamation permit subject to conditions in sub. 16.70, if appropriate. The permit decision shall be made no sooner than 30 days nor later than 90 days following receipt of the complete reclamation permit application and reclamation plan pursuant to this subchapter, unless a public hearing is held pursuant to s. 15. If a public hearing is held, the regulatory authority shall issue the reclamation permit, subject to conditions pursuant to sub. 16.70, if appropriate, or shall deny the permit as provided in s. 17, no later than 60 days after completing the public hearing.
  - (c) Permits issued pursuant to this subsection shall require compliance with a reclamation plan that has been approved and satisfies the requirements of s. 13 and provision by the applicant of financial assurance required under s. 14 and payable to The Town of Menasha prior to beginning mining.
- (5) **Automatic Permit for Local Transportation-Related Mines.**
- (a) The Town of Menasha shall automatically issue an expedited permit under this subsection to any borrow site that:
    - (1) Will be opened and reclaimed under contract with a municipality within a period not exceeding 36 months;
    - (2) Is a non-metallic mine which is intended to provide stone, soil, sand or gravel for the construction, reconstruction, maintenance or repair of a highway, railroad, airport facility or other transportation facility under contract with the municipality;
    - (3) Is regulated and will be reclaimed under contract with the municipality in accordance with the requirements of the Wisconsin Department of Transportation concerning the restoration of non-metallic mining sites;
    - (4) Is not a commercial source;
    - (5) Will be constructed, operated and reclaimed in accordance with applicable zoning requirements, if any and;
    - (6) Is not otherwise exempt from the requirements of this chapter under sub. 7.20(10).
  - (b) In this subsection, “municipality” has the meaning defined in s. 299.01(8), Stats.
- (c) Automatic permits shall be issued under this subsection in accordance with the following provisions:
    - (1) The applicant shall notify the Town of Menasha of the terms and conditions of the contract with respect to reclamation of the proposed borrow site.
    - (2) The applicant shall provide evidence to the Town of Menasha to show that the borrow site and its reclamation will comply with applicable zoning requirements, if any.
    - (3) The Town of Menasha shall accept the contractual provisions incorporating requirements of the Wisconsin Department of Transportation in lieu of a reclamation plan under s. 13.
    - (4) The Town of Menasha shall accept the contractual provisions in lieu of the financial assurance requirements in s. 14.
    - (5) The public notice and hearing provisions of s. 15 do not apply to non-metallic mining sites that are issued automatic permits under this subsection.
    - (6) Mines permitted under this subsection shall pay an annual fee to the Town of Menasha as provided in s. 27, but shall not be subject to the plan review fee provided in s. 26.
    - (7) The Town of Menasha shall issue the automatic permit within 7 days of the receipt of a complete application.
    - (8) If the borrow site is used to concurrently supply materials for other than the local transportation project, the automatic permitting in this subsection still applies provided the site will be reclaimed under a contractual obligation with the municipality in accordance with the Wisconsin Department of Transportation requirements.
    - (9) Notwithstanding s. 25, the operator of a borrow site under this subsection is required to submit only the information in an annual report necessary to identify the borrow site and to determine the applicable annual fee.
- (6) **Expedited Review.** Any operator of a non-metallic mining site may request expedited review of a reclamation permit application under sub. (1) or sub. (2) as follows:

- (a) The operator may submit a request for expedited permit review with payment of the expedited review fee specified in s. 26.20. This request shall state the need for such expedited review and the date by which such expedited review is requested.
  - (b) The operator may submit a request for expedited review under this subsection if the applicant requires a reclamation permit to perform services under contract with a municipality. This request for expedited review shall state the need for expedited review and shall include a copy of the applicable sections of the contract and the date by which the expedited review is requested.
  - (c) Following receipt of a request under this subsection, the Town of Menasha shall inform the applicant of the estimated date for decision on issuance of the permit. If the applicant then elects not to proceed with the expedited review, the fee paid under sub. (1) shall be returned.
  - (d) Expedited review under this subsection shall not waive, shorten or otherwise affect the public notice and right of hearing pursuant to s. 15. This subsection does not impose an obligation upon the regulatory authority to act upon a permit application under this subsection by a specific date.
- (7) **Permit Conditions.** Any decision under this section may include conditions as provided below:
- (a) The Town of Menasha may issue a reclamation permit or approve a reclamation plan subject to general or site-specific conditions if needed to assure compliance with the non-metallic mining reclamation requirements of this chapter.
  - (b) One required condition of the issued permit shall be that the new mine obtain financial assurance pursuant to s. 14 prior to beginning mining.

### 27.17 PERMIT DENIAL

An application for a non-metallic mining reclamation permit shall be denied as set forth below:

- (1) An application to issue a non-metallic mining reclamation permit shall be denied, within the time frame for permit issuance specified in s. 16, if the Town of Menasha finds any of the following:
  - (a) The applicant has, after being given an opportunity to make corrections, failed to provide to the Town of Menasha an adequate permit application, reclamation plan, financial assurance or any other submittal required by Chapter NR 135, Wisconsin Administrative Code or this chapter.

- (b) The proposed non-metallic mining site cannot be reclaimed in compliance with the reclamation standards contained in this chapter, Chapter NR 135, Wisconsin Administrative Code or Sub Ch. I. of Ch. 295, Stats.
  - (c) The applicant, or its agent, principal or predecessor has, during the course of non-metallic mining in Wisconsin within 10 years of the permit application or modification request being considered shown a pattern of serious violations of this chapter or of federal, state or local environmental laws related to non-metallic mining reclamation.
- (2) The following may be considered in making this determination of a pattern of serious violations:
- (a) Results of judicial or administrative proceedings involving the operator or its agent, principal or predecessor.
  - (b) Suspensions or revocations of non-metallic mining reclamation permits pursuant to this chapter, other reclamation ordinances, or Chapter NR 135, Wisconsin Administrative Code.
  - (c) Forfeitures of financial assurance.
  - (d) A denial under this subsection shall be in writing and shall contain documentation of reasons for denial.
- (3) A decision to deny an application to issue a reclamation permit may be reviewed under s. 22.

### 27.18 ALTERNATIVE REQUIREMENTS

- (1) **Scope of Alternative Requirements Approvable.** An operator of a non-metallic mining site may request an alternative requirement to the reclamation standard established in s. 11.00. The Town of Menasha may approve an alternative requirement to the reclamation standards established in this chapter if the operator demonstrates and the Town of Menasha finds that all of the following criteria are met:
- (a) The non-metallic mining site, the surrounding property or the mining plan or reclamation plan has a unique characteristic, which requires an alternative requirement.
  - (b) Unnecessary hardship which is peculiar to the non-metallic mining site or plan will result unless the alternative requirement is approved.
  - (c) Reclamation in accordance with the proposed alternative requirement will achieve the planned post-mining land use and long term site stability in a manner that will not cause environmental pollution or threaten public health, safety or welfare.

## TOWN OF MENASHA CODE

### (2) Procedures

- (a) The operator of a non-metallic mining site requesting an alternate requirement in sub. 18.10 shall demonstrate all the criteria in sub. 18.10. This shall be submitted in writing to the Town of Menasha.
- (b) The Town of Menasha Board shall act on requests for alternative requirements. Said action shall occur following a public hearing at which the operator, the community development department and all other interested parties are given an opportunity to present testimony on whether the alternative requirement should be granted. The Town of Menasha Board shall make their decision based on the testimony presented at the hearing.
- (c) A request for an alternative requirement may be incorporated as part of an application to issue or modify a non-metallic mining reclamation permit.

- (3) **Transmittal of Decision on Request for Alternative Requirement.** The decision on a request for alternate reclamation requirements shall be in writing to the applicant and shall include documentation of why the alternate requirement was or was not approved.

- (4) **Notice to Wisconsin Department of Natural Resources.** The Town of Menasha shall provide notice to the Wisconsin Department of Natural Resources as set forth in this subsection. Written notice shall be given to the Wisconsin Department of Natural Resources at least 10 days prior to any public hearing held under sub. 18.20 on a request for an alternate requirement under this section. A copy of any written decision on alternative requirements shall be submitted to the Wisconsin Department of Natural Resources within 10 days of issuance.

### 27.19 PERMIT DURATION

- (1) A non-metallic mining reclamation permit issued under this chapter shall last through operation and reclamation of the non-metallic mining site, unless suspended or revoked pursuant to section 27.32(2).  
*[Revised 05/07/01]*
- (2) If the mine operator is not the landowner, the reclamation permit duration shall not exceed the duration of the mine lease unless the lease is renewed or the permit is transferred to a subsequent lessee pursuant to s. 20.

### 27.20 PERMIT TRANSFER

A non-metallic mining reclamation permit issued under this chapter shall be transferred to a new owner or operator upon satisfaction of the following conditions:

- (1) A non-metallic mining reclamation permit may be transferred to a new operator upon submittal to The Town of Menasha of proof of financial assurance and a certification in writing by the new permit holder that all conditions of the permit will be complied with.
- (2) The transfer is not valid until financial assurance has been submitted by the new operator and accepted by the Town of Menasha and the Town of Menasha makes a written finding that all conditions of the permit will be complied with. The previous operator shall maintain financial assurance until the new operator has received approval and provided the financial assurance under this section.

### 27.21 Reserved.

### 27.22 REVIEW

Any permitting decision or action made by the Town of Menasha under this chapter may be reviewed as set forth in this section. Notwithstanding ss. 68.001, 68.03 (8) and (9), 68.06 and 68.10 (1) (b), Stats., any person who meets the requirements of s. 227.42 (1), Stats., may obtain a contested case hearing under s. 68.11, Stats., on the Town of Menasha's decision to issue, deny or modify a non-metallic mining reclamation permit.



**PART IV - ADMINISTRATION**

**27.23 PERMIT MODIFICATION**

- (1) **By the Town of Menasha.** A non-metallic mining reclamation permit issued under this chapter may be modified by the Town of Menasha if it finds that, due to changing conditions, the non-metallic mining site is no longer in compliance with Chapter NR 135, Wisconsin Administrative Code or this chapter. Such modification shall be by an order modifying the permit in accordance with s. 32. This modifying order may require the operator to amend or submit new application information, reclamation plan, proof of financial assurance or other information needed to ensure compliance with Chapter NR 135, Wisconsin Administrative Code or this chapter.
- (2) **At the Operator's Option.** If operator of any non-metallic mine that holds a reclamation permit issued under this chapter desires to modify such permit or reclamation plan approved under this chapter, it may request such modification by submitting a written application for such modification to the Town of Menasha at the community development department. The application for permit or plan modification shall be acted on using the standards and procedures of this chapter.
- (3) **Required by the Operator.** The operator of any non-metallic mine that holds a reclamation permit issued under this chapter shall request a modification of such permit if changes occur to the area to be mined, the nature of the planned reclamation, or other aspects of mining required by the reclamation plan approved pursuant to this chapter. Such application for permit modification shall be acted on using the standards and procedures of this chapter.
- (4) **Review.** All actions by the Town of Menasha on permit modifications requested or initiated under this section are subject to review under s. 22.

**27.24 PERMIT SUSPENSION AND REVOCATION**

- (1) **Grounds.** The Town of Menasha may suspend or revoke a non-metallic mining reclamation permit issued pursuant to this chapter if it finds the operator has done any of the following:
  - (a) Failed to submit a satisfactory reclamation plan within the time frames specified in this chapter.
  - (b) Failed to submit or maintain financial assurance as required by this chapter.
  - (c) Failed on a repetitive and significant basis to follow the approved reclamation plan.

- (2) **Procedures.** If the Town of Menasha finds grounds for suspending or revoking a non-metallic mining reclamation permit set forth in sub. 24.10, it may issue a special order suspending or revoking such permit as set forth in sub. 32.20.

(3) **Consequences.**

- (a) If the Town of Menasha makes any of the findings in sub. 24.10, it may suspend a non-metallic mining reclamation permit for up to 30 days. During the time of suspension, the operator may not conduct non-metallic mining at the site, except for reclamation or measures to protect human health and the environment as ordered by the regulatory authority pursuant to s. 32.
- (b) If the Town of Menasha makes any of the findings in sub. 24.10, it may revoke a non-metallic mining reclamation permit. Upon permit revocation, the operator shall forfeit the financial assurance it has provided pursuant to this chapter to the Town of Menasha. The Town of Menasha may use forfeited financial assurance to reclaim the site to the extent needed to comply with this chapter and the applicable reclamation ordinance.

**27.25 ANNUAL OPERATOR REPORTING**

- (1) **Contents and Deadline.** Annual reports that satisfy the requirements of this section shall be submitted by the operators of non-metallic mining sites on forms acceptable to the Town of Menasha.
  - (a) **Contents.** The annual report required by this section shall include all of the following:
    - (1) The name and mailing address of the operator.
    - (2) The location of the non-metallic mining site, including legal description, tax key number or parcel identification number if available.
    - (3) The identification number of the applicable non-metallic mining permit, if assigned by the Town of Menasha.
    - (4) The acreage currently affected by non-metallic mining extraction and not yet reclaimed.
    - (5) The amount of acreage that has been reclaimed to date, on a permanent basis and the amount reclaimed on an interim basis.
    - (6) A plan, map or diagram accurately showing the acreage described in pars. (d) and (e).
    - (7) The following certification, signed by the operator:

TOWN OF MENASHA CODE

*"I certify that this information is true and accurate, and that the non-metallic mining site described herein complies with all conditions of the applicable non-metallic mining reclamation permit and Chapter NR 135, Wisconsin Administrative Code."*

- (b) **Deadline.** The annual report shall cover activities for a calendar year and be submitted within 60 days following the end of the year.
  - (c) **When Reporting May End.** Annual reports shall be submitted by an operator for all active and intermittent mining sites to the Town of Menasha for each calendar year until non-metallic mining reclamation at the site is certified as complete pursuant to sub. 29.30 or at the time of release of financial assurance pursuant to sub. 14.10(7).
- (2) **Inspection in Lieu of Report.** The Town of Menasha may, at its discretion, obtain the information required in sub. 25.10 for a calendar year by written documentation of an inspection it completes during a calendar year, as set forth in this subsection. If the Town of Menasha obtains and documents the required information, the annual report need not be submitted by the operator. If the Town of Menasha determines that the operator need not submit an annual report pursuant to this subsection, it shall advise the operator in writing at least 30 days before the end of the applicable calendar year. In that case, the Town of Menasha shall require the operator to submit the certification required in sub. 25.10(1)(g).
  - (3) **Retention of Annual Reports.** Annual reports submitted under sub. 25.10 or inspection records that replace them under sub. 25.20 shall be retained by the Town of Menasha by the Town Clerk for at least 10 years after the calendar year to which they apply. These records, or complete and accurate copies of them, shall be made available to the Wisconsin Department of Natural Resources upon written request or during its inspection or audit activities carried out pursuant to Chapter NR 135, Wisconsin Administrative Code.

**27.26 PLAN REVIEW FEES**

- (1) **Amount and Applicability.** A person who intends to operate a non-metallic mining site for which a permit application has been submitted under sub. 12.30 shall submit a non-refundable plan review fee in an amount set forth in Appendix B Fee Schedule, reference this code section, plus an amount per acre in excess of 20 acres. 2000 Municipal Drive, Neenah, WI 54956. No plan review fee may be assessed under this section for any existing non-metallic mine site for which an application for an automatic reclamation permit is submitted that meets the requirements of sub. 12.20 or for any local transportation-related mining receiving an automatic permit under sub. 16.50. A separate

plan review fee shall be paid under this section for any modification to an existing reclamation plan submitted pursuant to s. 23. [Amended 11/28/05]

- (2) **Expedited Plan Review Fee.** A person who intends to operate a non-metallic mining site for which a permit application has been submitted under sub. 12.30 may obtain expedited reclamation plan review by paying a fee set forth in Appendix B Fee Schedule, reference this code section. Such fee shall be in addition to that required in sub. 26.10. An expedited plan review shall ensure approval of a plan within 10 business days of submittal subject to receiving a complete application. Failure of the Town of Menasha to approve a plan within that time period due to unforeseen circumstances shall only obligate the Town of Menasha to return the fee. [Amended 11/28/05]
- (3) **Relation to Annual Fee.** Any reclamation plan review fee or expedited reclamation plan review fee collected under this section shall be added to and collected as part of the first annual fee collected under s. 27.

**27.27 ANNUAL FEES**

- (1) **Areas Subject to Fees, Procedures and Deadline.**
  - (a) Operators of all non-metallic mining sites subject to reclamation permits issued under this chapter shall pay annual fees to the Town of Menasha, Community Development Department, 2000 Municipal Drive, Neenah, WI 54956. Fees paid under this section shall include both a share for the Wisconsin Department of Natural Resources under sub. 27.20 and a share for the Town of Menasha under sub. 27.30 that equals as closely as possible the costs of examination and approval of non-metallic mining reclamation plans and the inspection of non-metallic mining sites.
  - (b) Fees paid under this section shall be calculated based on the unreclaimed acres of a non-metallic mining site, as defined below:
    - (1) "Unreclaimed acre" or "unreclaimed acres" means those unreclaimed areas in which non-metallic mining has occurred after August 1<sup>st</sup>, 2001 and areas where non-metallic mining reclamation has been completed but is not yet certified as reclaimed under sub. 14.10(7). However the term does not include any areas described in par. (b).
    - (2) "Unreclaimed acre" or "unreclaimed acres" does not include:
      - (a) Those areas where reclamation has been completed and certified as reclaimed under sub. 14.10(7).

- (b) Those areas previously affected by non-metallic mining but which are not used for non-metallic mining after August 1<sup>st</sup>, 2001.
  - (c) Those portions of non-metallic mining sites which are included in an approved non-metallic mining reclamation plan but are not yet affected by non-metallic mining.
  - (d) Areas previously mined but used after August 1<sup>st</sup>, 2001 for a non-mining activity, such as stockpiling of materials used for an industrial activity such as an asphalt plant, concrete batch plant, block and tile operation or other industry that uses products produced from non-metallic mining.
  - (e) Those areas within a non-metallic mining site which the regulatory authority has determined to have been successfully reclaimed on an interim basis in accordance with subs. 29.20 and 29.30.
  - (f) Those areas defined as not included in a non-metallic mining site under sub. 10(16)(b).
- (c) Fees assessed pursuant to this section shall be based on unreclaimed acres at the end of the year. Such fees apply to a calendar year or any part of a year in which non-metallic mining takes place, until final reclamation is certified as complete under s. 29. Fees shall be paid no later than December 31 for the subsequent year. Fees shall be submitted with forms supplied by the Town of Menasha.
- (d) For new or reopened mines that submit a reclamation permit application under sub. 12.30, the first year's annual fee shall be based upon the unreclaimed acres which are anticipated at the end of that calendar year. The Annual fees shall be prorated by the number of months remaining in the year in which the application is made as authorized by s. NR 135.39(1)(b).
- (e) If reclamation has already occurred on portions of a non-metallic mining site, the fees for such portions may be submitted with a request that they be held by the Town of Menasha pending certification of completed reclamation pursuant to sub. 14.10(7). Upon such certification the Town of Menasha shall refund that portion of the annual fee that applies to the reclaimed areas. If the Town of Menasha fails to make a determination under sub. 14.10(7) within 60 days of the request, it shall refund that portion of the annual fee that applies to the reclaimed areas.
- (f) Wisconsin Department of Natural Resources Share of Fee. (1) Fees paid under this section shall, except where provided in sub. (2), include a share for the

Wisconsin Department of Natural Resources equal to the amount specified in Table 1. For sites on which no non-metallic mining has taken place during a calendar year, fees to be paid under this section for the following year shall be as stated in TABLE I to follow, and set forth in the Appendix B Fee Schedule, reference this code section. *[Amended 11/28/05]*

For non-metallic mining sites at which no non-metallic mining has taken place during a calendar year, the share for the Wisconsin Department of Natural Resources shall be \$15.00.

The Town of Menasha shall forward fees collected under this subsection to the Wisconsin Department of Natural Resources by March 31<sup>st</sup> of the year for which they were collected.

The Town of Menasha's share of fee. Fees paid under this section shall also include an annual fee due to the Town of Menasha as shown on the following tables. Said total fee including the fee for the Wisconsin Department of Natural Resources shall be submitted to the Town of Menasha with forms supplied by the Town of Menasha to 2000 Municipal Drive, Neenah, WI 54956.

**27.28 REGULATORY REPORTING AND DOCUMENTATION.**

- (1) **Reporting.** The Town of Menasha shall send an annual report to the Wisconsin Department of Natural Resources by March 31<sup>st</sup> of each calendar year. The reports shall include the following information for the previous year's non-metallic mining reclamation program:
  - (a) The total number of non-metallic mining reclamation permits in effect.
  - (b) The number of new permits issued within the jurisdiction of the Town of Menasha.
  - (c) The number of acres approved for non-metallic mining and the number of acres newly approved in the previous year.
  - (d) The number of acres being mined.
  - (e) The number of acres that have been reclaimed and have had financial assurance released pursuant to sub. 14.10(7).
  - (f) The number of acres that are reclaimed and awaiting release from the financial assurance requirements of this subchapter pursuant to subs. 29.10 and 29.20.
  - (g) The number and nature of alternative requirements granted, permit modifications, violations, public hearings, enforcement actions, penalties that have been assessed and bond or financial assurance forfeitures.
- (2) **Documentation.** The Town of Menasha shall, to the best of its ability, maintain the information set forth below, and make it available to the Wisconsin Department of Natural Resources for that agency's audit of the Town of Menasha's reclamation program pursuant to Chapter NR 135, Wisconsin Administrative Code:
  - (a) Documentation of compliance with Chapter NR 135, Wisconsin Administrative Code and this chapter.
- (3) The procedures employed by the Town of Menasha regarding reclamation plan review, and the issuance and modification of permits.
- (4) The methods for review of annual reports received from operators.
- (5) The method and effectiveness of fee collection.
- (6) Procedures to accurately forward the Wisconsin Department of Natural Resources' portion of collected fees in a timely fashion.
- (7) Methods for conducting on-site compliance inspections and attendant reports, records and enforcement actions.
- (8) Responses to citizen complaints.
- (9) The method of and accuracy in determining the amount of the financial assurance obtained from the operator to guarantee reclamation performance.
- (10) The maintenance and availability of records.
- (11) The number and type of approvals for alternative requirements issued pursuant to s. 18.
- (12) The method of determining the success of reclamation in meeting the criteria contained in the reclamation plan and subsequently releasing the financial assurance pursuant to sub. 14.10(7).
- (13) Any changes in local regulations, ordinances, funding and staffing mechanisms or any other factor which might affect the ability of the Town of Menasha to implement its non-metallic mining reclamation program under this chapter.
- (14) The amount of fees collected in comparison to the amount of money actually expended for non-metallic mining reclamation program administration.
- (15) Any other performance criterion necessary to ascertain compliance with Chapter NR 135, Wisconsin Administrative Code.

**27.29 COMPLETED RECLAMATION -  
REPORTING, CERTIFICATION AND  
EFFECT**

- (1) **Reporting.** The operator of a non-metallic mining site may certify completion of reclamation for a portion or all of the non-metallic mining site pursuant to a reclamation plan prepared and approved pursuant to this chapter and Chapter NR 135, Wisconsin Administrative Code.
- (2) **Reporting of Interim Reclamation.** The operator of a non-metallic mining site may report completion of interim reclamation as specified in the reclamation plan for the site prepared and approved pursuant to this chapter and Chapter NR 135, Wisconsin Administrative Code. Reporting of interim reclamation shall be done according to the procedures in sub. 29.10. *[revised 05/07/01]*
- (3) **Certification of Completed Reclamation.** The Town of Menasha shall inspect a non-metallic mining site for which reporting of reclamation or interim reclamation has been submitted pursuant to this subsection within 60 days of receipt, and make a determination in writing in accordance with sub. 14.10(7)(c). If it is determined that interim or final reclamation is complete, including re-vegetation as specified in a reclamation plan that conforms with s. 13, the Town of Menasha shall issue the mine operator a written certificate of completion.
- (4) **Effect of Completed Reclamation.** If reclamation is certified by the Town of Menasha as complete under sub. 29.30 for part or all of a non-metallic mining site, then:
  - (a) No fee shall be assessed under s. 27 for the area so certified.
  - (b) The financial assurance required by s. 14 shall be released or appropriately reduced in the case of completion of reclamation for a portion of the mining site.
- (5) **Effect of Inaction Following Report of Completed Reclamation.** If no written response as required by sub. 29.30 for an area of the mine site reported as reclaimed or interim reclaimed is given within 60 days of receiving such request, any annual fee paid to [name of county or municipality] for it under s. 27 shall be refunded.

**27.30 PERMIT TERMINATION**

When all final reclamation required by a reclamation plan conforming to s. 13 and required by this chapter is certified as complete pursuant to subs. 14.10(7) and 29.30, the Town of Menasha shall issue a written statement to the operator of the non-metallic mining site, thereby terminating the reclamation permit.

**PART V - ENFORCEMENT****27.31 RIGHT OF ENTRY AND INSPECTION**

For the purpose of ascertaining compliance with the provisions of Subchapter I of Chapter 295, WI Statutes, Chapter NR 135, Wisconsin Administrative Code, or this chapter, any authorized officer, agent, employee or representative of the Town of Menasha may inspect any non-metallic mining site subject to this chapter as provided below:

- (1) No person may refuse entry or access onto a non-metallic mining site of a duly authorized officer, employee or agent of the Town of Menasha or the Wisconsin Department of Natural Resources who presents appropriate credentials to inspect the site for compliance with the non-metallic mining reclamation permit, this chapter, Chapter NR 135, Wisconsin Administrative Code or subchapter I of Ch. 295, Stats.
- (2) Any person who enters the site under this right of inspection shall obtain training and provide their own safety equipment needed to comply with any federal, state or local laws or regulations controlling persons on the non-metallic mining site.

**27.32 ORDERS AND CITATIONS**

- (1) **Enforcement Orders.** The Town of Menasha may issue orders as set forth in Section 295.19(1)(a), Stats., to enforce Subchapter I of Chapter 295, WI Statutes, Chapter NR 135, Wisconsin Administrative Code, this chapter, a permit issued pursuant to this chapter or a reclamation plan required by s. 13 and a permit issued under this chapter. A violation of this chapter, an order or permit issued pursuant to this chapter or a reclamation plan required by s. 13 and a permit issued under this chapter shall be considered a violation of Subchapter I of Chapter 295, WI Statutes and Chapter NR 135, Wisconsin Administrative Code.
- (2) **Special Orders.** The Town of Menasha may issue a special order as set forth in Sections 295.19(1)(b) and (c), WI Statutes suspending or revoking a non-metallic mining reclamation permit pursuant to s. 24, or directing an operator to immediately cease an activity regulated under Subchapter I of Chapter 295, WI Statutes, Chapter NR 135, Wisconsin Administrative Code or this chapter until the necessary plan approval is obtained.
- (3) **Review of Orders.** A person holding a reclamation permit who is subject to an order pursuant this section shall have the right to review the order in a contested case hearing under s. 68.11, Stats., notwithstanding the provisions of ss. 68.001, 68.03 (8) and (9), 68.06 and 68.10 (1) (b), Stats.
- (4) **Citations.** The Town of Menasha may issue a citation under s. 66.119, Stats. to collect forfeitures to enforce

Subchapter I of Chapter 295, WI Statutes, Chapter NR 135, Wisconsin Administrative Code, this chapter, a permit issued pursuant to this chapter or a reclamation plan required by s. 13 and a permit issued under this chapter. The issuance of a citation under this subsection shall not preclude proceeding under any other ordinance or law relating to the same or any other matter. Proceeding under any other ordinance or law relating to the same or any other matter shall not preclude the issuance of a citation under this subsection.

- (5) **Enforcement.** The Town of Menasha may submit any order issued under s. 32 to abate violations of this chapter to a district attorney, corporation counsel, municipal attorney or the attorney general for enforcement. The district attorney, corporation counsel, municipal attorney or the attorney general may enforce those orders.

**27.33 PENALTIES**

Any violation of Subchapter I of Chapter 295, WI Statutes, Chapter NR 135, Wisconsin Administrative Code, this chapter, a permit issued pursuant to this chapter or a reclamation plan required by s. 13 and a permit issued under this chapter may result in forfeitures as provided in Section 295.19(3), WI Statutes, as follows:

- (1) Any person who violates Chapter NR 135, Wisconsin Administrative Code or an order issued under s. 32 may be required to forfeit an amount set forth in Appendix C Fines and Penalties, reference this code section, for each violation. Each day of continued violation is a separate offense. While an order issued under s. 32 is suspended, stayed or enjoined, this penalty does not accrue. *[Amended 11/28/05]*
- (2) Except for the violations referred to in sub. (1), any person who violates subchapter I of Ch. 295, Stats. Chapter NR 135, Wisconsin Administrative Code, any reclamation plan approved pursuant to this chapter or an order issued pursuant to s. 32 shall forfeit an amount set forth in Appendix C Fines and Penalties, reference this code section, for each violation. Each day of violation is a separate offense. While an order issued under s. 32 is suspended, stayed or enjoined, this penalty does not accrue. *[Amended 11/28/05]*
