For many communities across the country, October also starts the budget process for the upcoming year. Like many other communities, we here at the Town of Menasha struggle with "trying to do more with less" as the Town Board tries to keep tax rates as low as possible.

Many people don't realize the true cost of crime. These costs are generally associated with property stolen, which is a staggering amount...last year our victims of thefts and burglaries in the Town of Menasha lost on average over \$500! However we need to figure in plenty of other costs:

- Patrol officer response
- Detective investigation
- Potential lost work time for victim
- Potential medical costs for victim
- State crime lab analyze evidence
- Prosecution & court time
- Incarceration and/or supervision

It really doesn't cost that much money to prevent crime. It just takes a few extra minutes to make sure the doors are locked or to report that *weird* noise or observation. Spend a little time getting to know the neighbors or start a neighborhood watch group and invite an officer to your meeting. Awards



Town of Menasha Open Burning Restrictions

Every fall, we receive and respond to numerous complaints regarding the burning of leaves. We have included the section of the burning ordinance as it pertains to leaf burning.

Burning of Leaves

- 1. Burning of leaves must be conducted in an approved container.
- 2. Containers must be made of a non-combustible material and any openings shall be covered with a screen with not more than 1" openings.
- The location of containers for leaf burning shall not be less than 15 feet from any structure, combustibles or property lines and provisions shall be made to prevent the fire from spreading to within 15 feet of any structure.
- 4. Containers for leaf burning are limited to one container per parcel. A parcel is described as any contiguous property owned by a single individual.
- 5. Leaf burning may not be conducted when wind speeds are 10mph or greater.
- 6. Leaf burning may not be started with any type of accelerant.
- 7. There must be an ability to control or extinguish a leaf fire at all times.
- 8. Leaf burning may not be conducted after dusk and must be completely extinguished before dusk.
- 9. A responsible person must be present during the burning of leaves.
- 10. Burning of leaves may not be conducted in any prohibited areas.

Exception: Homeowners whose parcel is one acre or greater in size may burn leaves under the provisions of a maintenance fire provided they can meet all the provisions of a maintenance fire (see Town of Menasha Fire Prevention Code Chapter 5.16).
